PRIOR TO OUR FORCED SHUTDOWN, WE HOSTED FOUR PUBLIC PROGRAM EVENTS SOURCED VIA AN OPEN CALL PROCESS WHICH INVOLVED 20 ARTISTS AND PERFORMERS AND REACHED AN AUDIENCE OF OVER 1,000 PEOPLE.
